Minutes of last board meeting were read and accepted.

Trail report:

Memorial Park – Russell - arbor behind maintenance area – lst of year. Clearing top of triangle.

Vote was taken and passed to purchase Giftworks donation package – eventually cancelling the paypal account when up and running.
