#### 1. Membership report

**Huntsville:** KH says Ken Hilger waiting for heat to end before work parties start. RA to touch base **Double Lake**: downed trees on new section of trail. RA says R. Patrick doesn't have time/access. Forest service needs to be contacted (Jason Morton @USFS is the contact). Also federal rule: need to take Forest Service course/certification before mechanized tools can be used.

Volunteer options this weekend and next for trailbuilding. Pavers were dropped off and need to be moved to the new section.

Brandt Mannchen (Sierra Club) wants "adjustments." KH discussing with Ryan.

**Anthills:** P. Teitel – led parties successful. Rudy not very active. Wilcrest bridge ok'ed by Walt Peckham. RA asked P. Teitel to change wood rail and wires for handrail to wood rail and boards.

Bridge erosion control. RA thinks it should be addressed now with W. Peckham to protect the vertical posts. Chris Burke (Civil Engineer) and KH agree lets finish bridge and see how erosion go. RA wants minor erosion protection (secrete around pilings).
