Treasurer report

~\$21k checking bank acct.

~\$16k in TPW bank Grant Acct. Expecting \$15k from TPW, more later but will close out soon. Anthills spend: \$7k current Bill B. needs Anthills spend report for REI. Action Carla/Russell Expecting \$20k from NWCC for Huntsville. Raf raised question of having separate physical bank accounts to have clean separation. Tabled for Prez and Treaz to discuss.

Membership report

424 members as of now (includes household members). Lower enrollments than before due to lack of clinics or races.

X-mas party

~83 so far including BikeHouston, \$250 cash to band @party; Expecting \$450 from Bike Houston.

Contract to be signed and sent Action Carla Awards: Gift certificates were discussed.

Action: Complete recognition list ALL ON BoD (separate doc).

Veljko to print out certificates to hand out at party, Bill R. to write up public recognition article for website (after party). A few will receive special recognition (tbd decided next mtg).

Trails

Anthills

3 bridges built on 6 work parties. Still need to remove old Wilcrest bridge and materials.

Wilcrest bridge took 206 man-hours out of 350 total; \$2200 spend. 2011 Goals: Update all bridges.

Find a high water line for some bridges.

Memorial have 3 people to lead wps: Julia, Chris and Justin. Big maintenance needed at MP. Priorities to be worked.

Cywood. John and Jerry ideas for site solutions, but Russell needs priorities. Potential layout of asphalt trunk line trail reviewed for the long term future of trail. P4 contacted to

supply materials for existing natural surface trails. J. Roberts did a GPS walkthrough of existing trails.

JBP: Booker has had good turnouts

Flintridge 1 wp, no known results

Huntsville SP, not a lot of action.

Double Lake. status of signage, completion of trail (will it impact our budget) Sugar Land: Greg Vaupel working Brindle trails. Dan no news on new trail.

Advocacy Report - Kevin

Double Lake

IMBA walked through and reported. S&S coming Dec 13. to address issues from IMBA report. Also, a re-route needed to satisfy Sierra Club.

Signage plan. J. Dowling to make forest service approved signs. Punch list needs to be closed out to have FS ban horses, guns, atvs.

Volunteer agreement - for FS to be distributed online. J. Mackey now Trails Steward. Overall project is still in budget (TP&W Grant will be completely used up).

Huntsville SP will have \$180k to spend.

City of Hunstville and hikers will also have trail projects. Saturday Dec 4 meeting went well. Hikers' LS Trail will remain hiking only in existing location. Grant contract coming soon. RfP's going out.

SHTC trails committee mtg. A combined map is being produced. Decided to authorize 4 grant requests: equestrians; motorized in west part of forest; \$250k bridge multi-use; Magnolia section of LST is a choke point. Options to get grant and share entire 6.4 mile trail.

SHTC Mtg. vote on what grants to pursue. RTP grant deadline is Feb 1. Any trail building project needs to be under SHTC auspices.

Clarification of BOD responsibilities / titles

Advocacy Director title approved (not a board position).

2011 Grants

- 1. Obtaining grants for GHORBA 2011. An email vote on spending grant money on professional trail building was not clear.
- Kevin: RTP grant deadline Feb. 1. We could get a substantial grant for an existing or new trail. It's possible RTP grants won't be available in future years. Options: One option is to fund the Magnolia Trail (parallel construction). Also, a grant for Brazos River Trails that would be city of Sugar Land's; we would only support it, but not be the owners. Russell raised concerns of unfinished projects and effort dilution, plus commitment of

support.

Long discussion on using grant money. We don't know how much we need or want. Another option is to seek grant money for ALL existing trails. Action Kevin to draft proposal.

2011 Budget TABLED for Jan mtg.

- 1. GHORBA funds for local trails
- 2. purchase of a electronic race monitoring system-Raf
- 3. social/GHORBA program funds
- 4. Investment Matrix tool by Mychael -. How do we rank the Location/Size/Color of the balls?
