- Big Ring Challenge: race rut repairs remain ongoing, difficult with the 18" of rain that fell between the BRC and last weekend. We have paid the 3% revenue fee per the Permit (a discount from 5%, contingent on a second race. If the Huntsville Race does not occur, we need to pay 2% more).
- Double Lake: There are numerous wet spots and reports of the trail being sloppy, getting worse by people riding the high side and resulting in braided trail. We may need to formally close some sections rather than the informal closure the Forest Service has allowed. Jim Mackey has repeated his request for some tru-grid pavers; I will purchase this week using up to \$1000 from my volunteer hour corporate match.
- Huntsville Classic: I've been speaking with TPWD and Huntsville State Park and sent in a draft permit for November 3-4, but it's too far out to proceed. I need to meet with the new park superintendent to discuss options contingent on C57. This will move ahead following the TMBRA meeting at Warda, May 19-20.
- Texas Trails and Active Transportation Conference: I've been accepted to speak on May 4 with Ryan Spates about how to make Texas trails and gravel/bikepacking a tourist destination. I can only attend the conference that Friday due to a lack of vacation days.
- 2019: I will be race director through the Huntsville Classic, but am likely to resign following that
 race. I do not affiliate as a mountain biker, and I have never raced a TMBRA race, or any XC
 mountain bike race except for 1 DNF marathon race. It seems like it would be a better fit for
 someone who actually races the TMBRA series. It's time to think about how to put on two races
 and be sustainable.
