GHORBA will be re-organized as a federation of regional trail groups with a goal of providing greater inclusion for our trail groups, members and the Greater Houston off-road cycling community, with a modified board of directors as follows:

- 1. An executive board, elected by members in accordance with current bye-laws;
- 2. An advisory board comprising representatives from each regional trail group and additional general members as required.

Details:

The executive board will comprise the minimum required elected members of

- 1. President
- 2. Vice-President
- 3. Treasurer
- 4. Secretary

The trail groups providing representatives will be as follows:

- 1. Sam Houston National Forest trails:
 - a. Double Lake (DL)
 - b. Huntsville State Park (HSP)
- 2. Woodlands/Conroe
 - a. Flintridge
 - b. Carl Barton
- 3. Kingwood / Houston NE
 - a. Lake Houston
 - b. Timber Lane
 - c. Spring Creek
- 4. Cypress Creek
 - a. Cypresswood
 - b. Cypress Creek
 - c. Bridgeland
- 5. Memorial Park
- 6. Anthills
- 7. Sugar Land
 - a. Brazos River trails
 - b. Cullinan Park
 - c. Oyster Creek
- 8. Jack Brooks

Each group is encouraged to provide two representatives to attend meetings, but there will be one vote per group.

General members of the advisory board shall comprise the following:

- 1. Trails Director
- 2. Membership Director
- 3. Advocacy

- 4. Events
- 5. Race Director
- 6. IT/Communications

The trail groups / reps can be amended as they develop, and the other advisory board members can also be adjusted to suit.

Further major changes will be implemented once the new board is in place. This includes the IMBA affiliation. Decisions will be made by the full board - executive and advisory - but the executive board will always have the ultimate (legal) authority. We hope that future leaders will come from the expanded advisory board.

Vote passes with seven (7) ayes. No nays.

IMBA - Will be worked out with the new enhanced board in the next meeting.
