#### **New Board Development**

The goal of this meeting is to set the course for the future of the off-road cycling community in our region to learn from our collective experience, to build on our strengths and learn from our weaknesses. The key weakness of GHORBA is a failure to connect as a club – our membership is tiny compared to the

number of riders and we have failed to put on community events, besides the BRC race and the singular exception of the recently successful 20th Anniversary event at Memorial Park.

We have several key strengths in our organization:

- Financial strength GHORBA has been successful in fund raising from donations, grants and the BRC race, among other things;
- Advocacy GHORBA has a good name among land managers and we continue to leverage this with new trail development opportunities;
- Community the growing communities developed around individual trails, each with its own Facebook group.

The broad plan is to convert GHORBA into a coalition of these groups, each with its own identity and autonomy, but still working together under the GHORBA umbrella. GHORBA will continue to manage the routine, but important, issues of membership, finance, insurance and oversight of advocacy.

Advocacy is one area that each group needs to have increased authority. There are many opportunities and issues – too many for a single person on the GHORBA board. The key thing is to advocate according to unified guidelines on our business model and mode of operation – we need to be consistent about what we can and cannot do.

The organization will be based on a formally elected board with the basic number of members — covering President, VP, trails, secretary, treasurer, membership, advocacy, events, communications. The advisory board will comprise representatives from each main trail group — the list will be developed at this meeting, though it can be adjusted at any time. We would like two (2) reps from each group, but each trail has one vote. Decisions on GHORBA matters will be made with the consensus of the advisory board, but formalized by the "executive" board. In the event of ties, or conflicts, then the executive board must have the final say — though this should be a rare event.

Do we want FBMBA to have a rep with GHORBA?
