### Reviewed Advocacy update from Advocacy Directors email which was sent prior to the meeting.

Precinct 4: Meeting with Dennis Johnston last week. Exchanged messages with Ben Stinsman - the scheduler for Comm. Cagle - and he's put the 3/26 event in their calendar - he would like to receive a flyer as soon as we have it.

Precinct 3: No further comms with P3 after we got permission from Steve Dorman on the 3/26 event. On P3/P4 - we're getting into the end game before the complete switch of operations at the end of this month and we'll have to see where we are after that.

Montgomery County: John Martin is going to lead advocacy up there. We spoke yesterday and the City of Conroe wants our input on their bike master plan and support for a TPWD grant (Dennis will sign a letter). Our former President, Christy Miller Jones, has been speaking with The Woodlands Township Parks as they are talking about building more MTB trails and apparently they've been touching base with the City of Sugar Land for feedback, which is a good sign. John will follow up and dive in there. John will also follow up with BLC on their plans for Spring Creek Nature Trail and personnel changes.

SHNF: Need to catch up with Ricardo Valdez and see how he's doing with the SHTC.

HCFCD: We will now vote to approve this agreement, my vote is yes, we approve and execute the agreement ASAP, but along with this my proposal is that GHORBA institute strict risk management guidelines - all volunteers sign a waiver, JHA completed and "tool box talk" before each work party, strict guidance on PPE and use of power tools, especially chain saws. We also need to ensure all work party leaders understand the notification and reporting requirements for every work party.
